### **Preamble / Promulgation Clause**

Based on Article 249 para. 2 of the 2016 Insurance Supervision Act (VAG 2016; Versicherungsaufsichtsgesetz 2016), published in Federal Law Gazette I No. 34/2015, last amended by federal act in Federal Law Gazette I No. 68/2015 the following shall be determined by Regulation:

### Text

### **General requirements**

**Article 1.** (1) The assets entered into the *Deckungsstock* list pursuant to Article 249 para. 1 VAG 2016 shall be marked in accordance with the separate *Deckungsstock* groups pursuant to Article 300 para. 1 nos. 1 to 8 VAG 2016.

(2) The assets entered into the *Deckungsstock* list are to be marked with Complementary Identification Codes (CICs) set out in the Annex to Article 1 of the Regulation of the Financial Market Authority (FMA) on Reporting to the FMA by Insurance Undertakings and Reinsurance Undertakings (Insurance Undertakings Reporting Regulation (VU-MV; Versicherungsunternehmen Meldeverordnung), published in Federal Law Gazette II no. 217/2015.

### Backing up of data

**Article 2.** The backing up of the data shall be conducted in such a way in the undertaking that it shall be possible at all times to fully recreate all data, provided that and as long as they are subject to legal retention periods, in written form or by means of electronic data transmission. In the case of changes being made to the data processing system, it must be ensured that the originally stored data in accordance with the legal retention periods is also traceable following such changes to the system.

### Contents of the Deckungsstock lists

Article 3. The *Deckungsstock* lists shall be required to contain the minimum information as prescribed in Annexes A to H.

### Entry into force and transitional provision

Article 4. (1) This Regulation shall enter into force on 01 January 2016.

(2) Statements from the *Deckungsstock* lists for the reporting date of 31 December 2015 shall be submitted to the FMA in accordance with the Regulation of the Financial Market Authority (FMA) on the keeping of lists for the assets by contractual insurance undertakings dedicated for the covering of technical provisions (List Regulation for Contractual Insurance Undertakings; VerzVVU; Verzeichnisverordnung), published in Federal Law Gazette II No. 505/2002 in the version of the Regulation amends in Federal Law Gazette II No. 272/2011.
