Drafting Guidance for Heads of Internal Control Functions (Head of Compliance, Head of Internal Audit, Head of Risk Management)

General remark:

Notifications for heads of internal control functions according to Art 73 (1) 11 BWG, Art (1b) 1 and 2 BWG need to use the same questionnaire as members of the management body. However, as several criteria do not apply to them, they may follow the following drafting guidance in order to be able to submit the questionnaire without filling in information on criteria that do not apply to them!

Specific drafting guidance:

Section 2 Function for which the questionnaire is submitted

Formal independence: select 'Not applicable' ٠

Section 3 Experience

D presumption: enter 'Yes' as default value •

Section 5 Conflict of Interest

D cooling-off period: enter 'No' as default value •

Section 6 Time commitment

- A to H: for all free-text fields KFH enter e.g. 'N/A' as default value D: for fields other than free-text, enter: Function within the entity: KFH (Key Function Holder) Privileged counting: 'No counting' Time empiriment: wurdtdeve previoes e.g. 240
